

WARRANTY INFORMATION

UNLESS A WARRANTY IS SPECIFIED ON INVOICE, PURCHASERS UNDERSTAND THAT THE PART IS SOLD "AS IS" AND THE PURCHASER ASSUMES ALL RISK.

Seller warrants to the ORIGINAL RETAIL PURCHASER any part it sells to be free from defects for a period of ninety (90) days after date of purchase. If part fails in the normal use or service, sell will furnish a replacement part, or will refund the purchase price of the part as its option, subject to the condition and exception listed below.

This warranty is subject to the following conditions:

- Unless otherwise noted on invoice, warranty expires ninety (90) days after date of purchase.
- Invoices must accompany all claims under warranty. All warranty claims must be presented to an authorized agent or manager of 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts within a period of ninety (90) days from date of purchase for this warranty to be valid.
- 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts, at its option may replace the part(s), repair the part, or refund the original purchase price.
- Merchandise must be returned to seller.
- Seller must be notified of any defective transmissions, axle assemblies, and engine assemblies prior to any repairs before warranty coverage will be considered.
- New fluid, filters, seals and gaskets must be used in installation of part. Engine oil must be of the proper viscosity for the engine and transmission fluid must be the type recommended by the manufacturer of the vehicle. All fluids must conform to manufacturer specifications for the vehicle. The engine your purchases must have new oil and new filter installed upon installation and every 3,000 miles thereafter (Must be Documented).
- Claims related to the overheating and/or improper lubrication of the engine or its components are not covered by this warranty.
- Timing belts, water pump, thermostat, spark plugs, fluids and seals are routine maintenance items and should be replaced at the time of installation and at the vehicle manufacturer's recommended service intervals.
- Proper operation of the cooling and electrical system must be checked during the installation of products that can be affected by those systems.
- Warranty does not included carburetors, water pumps, fuel pumps, intake manifolds, exhaust manifolds, plugs, wires, distributors, fuel injectors, timing belts, oil pans, any and all gaskets and seals. These items are not warranted when sold on an engine and often need to be switched-over from the original engine.
- Warranty is void if heat tabs are melted or removed. When an engine runs at a temperature of 250 degrees the center of the tab will melt. Any temperature above factory recommendations will cause permanent damage.
- Transmissions are warranted to be in good working order, against slippage or shifting failure if properly installed. All transmissions are sold without fluid. The seals and filter, if equipped must be replaced. Transmissions lines and transmissions cooler must be flushed. If they are not,

warranty is void. The transmission is to be filled with original manufacturer's recommended fluid (must be documented). Speed sensors are not warranted and must be replaced if found defective. Excluding from this transmission warranty are the transmission mounts, shifting linkage, flywheel, all other external parts, and problems that result from not installing new fluid, filter and seals when installing the transmission. If the transmission is electronically controlled, the system must be programmed to allow proper operation. Failure to follow these instructions will result in a null and void warranty. It is responsibility of the installer to replace the radiator or transmission oil cooler, flush the transmission oil cooling lines, fill differential, adjust shifter mechanisms, replace filters, replace seals, replace pan gaskets and reset or replace computer codes when installing a transmission.

- All A/C systems must be flushed. A new dryer, accumulator and orifice tube must be installed prior to installing the new A/C compressor. 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts is not responsible for labor, loss of time or use Freon or gaskets, etc.
- All implied warranties are limited to the terms of this limited warranty. Consequential or incidental damages are not covered under this warranty. Warranties on any product sold shall be in effect only for the duration of the expressed warranties contained herein and upon conclusion of the expressed warranties therein, there shall be no warranties expressed or implied including merchantability and fitness for use on the product sold. This warranty is not transferable and does not cover damage. If parts are used in connection with racing purposes, or damage by accident or misuse.
- IMPROPER INSTALLATION WILL VOID WARRANTY.
- NO LABOR WARRANTY IS INCLUDED.

- Warranty does not cover claims that result from overheating, accident, abuse, neglect, alteration, improper maintenance or improper installation. Broken teeth on standard transmission gears, axle rings, and pinion gears.
- Warranty does not cover parts installed in vehicles used for commercial, racing, or off-road purposes or any part used under conditions that would cause greater than normal wear.
- Warranty does not cover parts used for something other than original purpose.
- The year and model of the vehicle or part printed on this invoice is within a range of interchangeability and may not necessarily be the exact model and year as the part that has been provided.
- Windshield and other glass breakage are not covered under this warranty.
- Any recommendation installation procedures provided by 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts must be followed by the installer to maintain warranty coverage.
- 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts is not responsible for injury or damages during, or as a result of, the installation of our product.
- In the event of Failure, the purchaser must use all reasonable means to protect the product from further damage and must return the original defective product to 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts. The purchaser must return the original

RETURN POLICY

All claims and returned goods must be accompanied by the original invoice. All correctly filled orders which are returned will be charged a 20% restocking fee. Parts must be returned within 15 days of purchase. No return on special ordered items. Core returned for refund must be returned within 30 days to obtain a refund. When buyers paid by check or bank draft, refund will be given by check 15 days from date of purchase. This will allow for purchaser's check to clear. We reserve the right to inspect any product prior to replacement.

GENERAL TERMS

At the time of the return of the parts by this warranty, 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts will pay the original purchaser of the part listed on the front of the invoice up to the amount noted on the invoice if 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts determines that the part failed within the period of the Limited Parts Warranty for the period of an extended warranty if one is purchased on the same invoice. All conditions of the original limited parts warranty must be met. 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts retains all rights under the Limited Parts Warranty, including the right to repair any part from 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts but must determine that part must be replaced. This limited part warranty must be billed on the same invoice as the parts described by the part type and 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts stock and signature of the invoice. The liability and obligations of 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts under this warrant shall not exceed the amount shown on the invoice and shall not include inconvenience, transportation, towing, down time and/or direct indirect consequential damages or delay resulting from defect. This warranty is in lieu of any other warranty expressed or implied, including any implied warranty or merchantability or fitness for a particular use. No action by 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts under this warranty shall extend the original warranty or after its obligation.

The purchaser hereby understands that due to the nature of used auto parts, any liability of 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts from all causes shall be limited to the price paid for the goods sold or provided. If a part sold by 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts is defective, liability shall be limited to the replacement of the part or a remedy not to exceed the price paid for the part, at 6901 Coral Way Management, LLC, DBA East Colonial Auto Parts' option.
